# **Open Payments Program Reminder**

The Open Payments Program, which was made final in 2014 as a requirement of the Affordable Care Act, is a reporting mechanism with information about drug or medical device company relationships with physicians. Drug and/or medical device companies report any relationships with physicians to CMS, and CMS allows a review period for physicians before making that information public. 2016 reported data will be published on June 30, 2017 and **physicians have until May 15<sup>th</sup> to review and dispute this information if necessary**.

In order to review the data, the physician must first be registered in Open Payments. The physician's NPI number, DEA number, and State license number will be required in order to register if this has not yet been done. The registration system can be found in the CMS portal at the link below:

## Task Documentation

Tasks in Allscripts which are related to specific patients are part of that patient's legal medical record. When sending patient-related tasks, all communications should be professional and appropriate as they will be forever integrated in the patient's chart. Any communications that are not appropriate for the chart or unrelated to a specific patient should be documented in a non-patient-related task or sent via email or another secure means of communication. Patientrelated tasks that are part of the medical record can be requested for
